### Course Outline

This course is designed to teach you the principles of body piercing. The courses are all one on one to allow you to receive the full benefit of our experience and are made up of a combination of home study, written tests and practical piercing experience with the added benefit of post course follow-up.

There are different training levels available to suit either total beginners or people with no practical piercing experience but who have knowledge of a related industry which has allowed them to gain some knowledge of Environmental Health legislation. The course cost and the amount of theory time you spend in the Ramsbottom studio will vary in accordance with your chosen package.

If you are already piercing but would like to learn additional skills as stand alone modules, you can learn Microdermals or Genital Piercings as a stand-alone module. This training can be carried out at your own studio if desired (travel costs will be added in this case). If you are returning to piercing after an absence and would like to book a day of live model practice, this is also something which is offered.

**A certificate of competence will be issued subject to satisfactory course completion.**



### Course Cancellation Terms

If the course booking is cancelled with less than **28 days** notice before the date of your practical course, a cancellation fee of **£250** will be charged. If the course is rearranged for a date within 3 months of the original course, the cancellation fee will not be charged. **If your course is cancelled following non-payment of your outstanding balance and there is less than 7 days to go before you are due to attend, the course fee remains payable in full.**

Your local authority will be advised that a course was booked by you and subsequently not attended. This is to prevent you applying for a licence and using our course as proof of knowledge.

### Course Content – Home Study

When you book onto a course, you will receive a home study pack which consists of technical and biological information relating to different types of piercing as well as information about setting up a studio and relevant legal documentation. At the end of the study booklet there is a written test which you must complete prior to attending your practical course.

### Course Content – Practical Course

The live model assessment part of the course is based at the Angel Face studio in Ramsbottom and lasts for a full day. During the course of the day you will work alongside the professional piercer and carry out between 10 and 15 piercings of your own. Your studio theory days will take place on the day(s) immediately preceding your chosen live model practical date.

Prior to carrying out any piercings, you will learn about studio hygiene, basic first aid and studio equipment as well as Health and Safety and local authority piercing regulations. You will be required to complete a short written test on the above subjects.

### Course Content – Follow-Up

Should you choose to begin your piercing career straight away, you will be offered on-going access to advice and support from Angel Face Jewellery. Should you wish to undertake additional live model practice following your course, this can be arranged for an additional cost as outlined above.

## COURSE LOCATION

- The practical element of the course is based in **Ramsbottom, Lancashire**. The postcode is **BLO 9AY**
- The majority of the course will be home-study based
- The practical element encompasses either 3 full days or 1.5 days depending on your chosen assessment package

## COURSE CONTENT

- The course covers above and below waist as well as Microdermal piercings however live model assessment focusses on above waist and dermal piercings in order to build confidence and assure safety.
- The course material comprises an information book, training videos and written and practical assessment.
- The training DVD's show a method known as Blade Piercing as well as Cannula piercings but we practice with Cannula needles during the practical assessment so that students can experience both techniques

## COURSE PAYMENT

- Payments can be made by Paypal, credit/debit card or bank transfer.
- A non-refundable deposit of **£250** is required to secure your chosen practical date. Your theory days will immediately precede your chosen live model assessment date.
- Payment of a course deposit constitutes full acceptance of the course terms
- The remaining balance is payable **two weeks** prior to your practical assessment
- The course is subject to cancellation deadlines which are outlined on the main page or can be sent to you as a document
- Failure to pay an outstanding balance as it becomes due will result in you losing your place on the course and if the course was not cancelled using the proper process, any outstanding financial amounts will be formally recovered as described above.

## DATA PROTECTION

- Training records are held electronically. We store them in a secure archive. You will be sent a copy of the documentation relating to your course upon it's completion. This will become your own property.
- A copy of your training record may be requested from us by your local authority when you apply for your licence. We will always contact you to obtain your permission to send information to a third party.
- We hold copies of course completion certificates for six years. This is because if one of our former students uses his/her course certificate when applying for a new job, or if a former student is ever the subject of a serious Health and Safety/ Environmental Health concern, a local authority or a solicitor may request proof that training was completed.
- Our former students often keep in touch to ask for advice. If as a former student you wish to ask us for advice relating to one of your current clients. it will be **your** responsibility to ensure that you have their permission to share any photos or information you wish to send to us. For our part, we will delete the information within 30 days of a resolved enquiry.
- We do not provide detailed personal references to employers or local authorities but will be happy to confirm whether or not a person has satisfactorily completed a course and when their certificate was issued.
